- 4 If you intend to postpone your place until the following intake, you will need to pay the remaining tuition fee. You will be permitted to do so only at the discretion of BSBI.
- 5 The scholarship is not transferable to another student.
- 6 In the event that a student does not attend a programme through serious unforeseen circumstances (death, accident, or serious illness) a specific committee will examine each case on an individual basis.
Attendance is compulsory. An attendance rate of less than 90% will lead to scholarship withdrawal.
- 7 The scholarship is for the ONE named person and BSBI will not be responsible for a scholar's family members/spouse/children etc.
- 8 BSBI may also use information collected regarding the scholars in the School marketing activities; however, students' addresses and telephone numbers will not be given out without permission from the student via a request from BSBI.
- 9 BSBI may feature your interview/photo/profile/story on the BSBI website and/or other School publications and will ask for your permission/approval prior to publishing this.
- 10 Please note that when requested scholars are required to show originals (not photocopies) of transcripts and documents submitted in evidence with their scholarship application, and present these to the Scholarship office, if there is any question of authenticity. If BSBI discovers any documents that are NOT 100% genuine, the scholarship award will immediately be invalidated and withdrawn. The School accepts NO liability in this case.
- 11 It is the scholar's responsibility to set a good example, e.g. strive for best results, attend classes, finish the course on time and continue to demonstrate the exemplary student attributes/grades by which he/she was awarded the scholarship.
- 12 By invitation only, scholars will take part in welcoming new students to the scholarship programme.
- 13 The BSBI Scholarship panel will not provide information regarding the non-awarding of scholarships and the panel's decision is final.

The information you provide on this application form will be processed in accordance with GUS Group’s Privacy Notice which can be found on our website. Data Controller

Purpose of the Processing

We will use the details provided by you in this application to consider and process your application. We share your application and the personal data supplied in it with Global University Systems which carries out part of the application process for us. We enter into a contract with them which prohibits them from using your data for any purpose other than to perform the contract with us.
