On Vygotsky's Constructivist Social Learning Theorem

In this article, based on my research works (1) "Logical Foundation of Inductive Meaning Constructing in Constructivist Interactions" (Brill, 2019) and (2) "A Theoretical Model for Meaning Construction through Constructivist Concept Learning" (AAU Press, 2017), I focus on Lev Vygotsky's role in the development of social constructivism. Constructivism is a philosophical, epistemological and scientific position that expresses that the phenomenon of 'knowledge' gets manifested based on various active processes of construction in any individual cognitive/knowledge agent's mind.

I believe that *constructivism* is how any individual human being deals with his/her learning process in order to turn it into his/her own 'knowledge constructions'.

Lev Semyonovich Vygotsky (1896 – 1934) was a Soviet thinker and theorist in the area of developmental psychology. He was the founder and the originator of a theory of human cultural and bio-social development, commonly referred to as *cultural-historical psychology*.

In my opinion, Vygotsky's 'social learning theory' has made a strong backbone for the development of *constructivism* in social (i.e., communication-based and interaction-based) contexts. According to Vygotsky's [constructivist] social learning theory, we have the following three major themes: (1) humans' social interactions (e.g., student-student interaction, student-teacher interaction), (2) the more knowledgeable other and (3) the zone of proximal development.

Vygotsky believed that the first theme, or 'social interaction', plays a fundamental role in the process of humans' cognitive development. Vygotsky said: "Every function in the child's cultural development appears twice: first, on the social level, and, later, on the individual level; first, between people (inter-psychological) and then inside the child (intra-psychological)."

Regarding the second theme, or 'the more knowledgeable other', he believed that the More Knowledgeable Other (MKO) refers to any individual who has a better comprehension and understanding (of some concept, task or process), or even a higher ability level, than the

learner (with respect to that particular concept, task or process). According to the second theme, we can believe that MKO can be a mentor, instructor, supervisor and teacher.

Finally, regarding the third theme, it can be believed that the Zone of Proximal Development (ZPD) is, in fact, the distance between a learner's (i) ability to perform a task under some guidance and/or with peer collaborations and (ii) the ability to solve the problems independently. In more specific words, ZPD expresses some [conceptual and logical] space between what some student may do without the assistance of someone, say his/her teacher, as well as what he/she can do with the support of (or based on the collaborations with) that person.

Note that Vygotsky believed that the phenomenon of 'learning' occurs and becomes manifested in ZPD. In fact, relying on their cognitive capabilities and on their social interactions (with other students as well as with their teachers), students—conceptually, cognitively and logically—move into their ZPD.


It should be stressed that student-teacher interaction plays a very important role in (and, in fact, makes a very important context for) this framework. An interaction between a student and his/her teacher can be interpreted through their coactivations (consisting of their shared actions and transactions). More specifically, within a student-teacher interaction, they both become concerned with their co-activations (i.e., their collaborations, co-operations and co-ordinations). In this framework, they exchange questions, answers, actions and transactions concerning their multiple descriptions, specifications, explanations and justifications (of/about the world).








Tourism

The most significant event in the domain of tourism in the past week was launched at the High-Level Political Forum on Sustainable Development, which focused on this year's theme of 'building back better' from the pandemic, the UN reports draw on UNWTO's statistical work to track tourism's role in delivering meaningful progress for people and the planet. Specifically, the UN SG Progress report on SDGs with its statistical annex will serve as an input to the deliberations of the HLFP. Alongside this, the Sustainable Development Goals Extended Report is aimed at the wider public and provides an overview of all 17 Goals with infographics, including those illustrating the relevance of tourism. As demonstrated in the section on SDG8 ('Decent Work and Economic Growth'), tourism was one of the most affected economic sectors by the Covid-19 Pandemic as global GDP from tourism nearly halved between 2019 and 2020, with wide-reaching consequences for jobs, local businesses and conservation efforts.

FC Barcelona is the second most valuable sports team in the world, worth \$4.76 billion. Despite the fact that it is also the fourth richest football club in terms of revenue, with an annual turnover of €582.1 million, in March 2021, Barcelona was technically bankrupt. Just one year ago, the club borrowed \$605 million from Goldman Sachs and in October 2021, reported \$1.56 billion in debt.

The necessity for fresh capital follows heavy financial losses for Barcelona over the last year but has already taken several steps to prevent financial collapse by getting creative with their finances. The club has agreed to sell 10% of their league TV rights for the next 25 years in return for \$207.5 million, mortgaging in this way their future for the present. It also plans to sell off a 49.9% stake in its licensing division. In a \$300 million deal with Spotify, the team will rename their stadium and feature them on their shirts. Spotify will become the main sponsor of the club.

These are risky moves to put future profits at risk in the hope that Barcelona could rake in more income in the short term.
